A representative of Meadowview Commons asked what to expect in water increases so they can plan their budget. A resident spoke about the library proposal. Tim Moller stated the village council should pass a resolution stating that any future plan for expansion of the Island House should be put to a vote by the residents of the Village of Elk Rapids. - **A.** ASSISTANT MANAGER/CLERK CAROLINE KENNEDY Staff received CPR and AED training from Officer Bradley; we should hear the results of two different grant applications this month; the village was awarded \$15,000 from the Hildreth Foundation toward refurbishing the basketball courts at Veterans Memorial Park; there is a citizen group of tennis and pickle ball players that are willing to provide gap-funding for refurbishing those courts.
